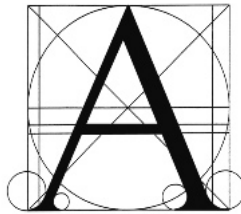
ATTENTION AUTHORS

AND ANYONE WISHING TO PUBLISH AN ARTICLE

★

*Each author has the right/duty to contribute in every way to the excellence of their contribution, whether in the phase of preparation for printing, conforming to the high editorial and scholarly standards of the journal, or after publication. S/He exercises this right / duty within the framework of a preliminary acceptance of the journal's editorial line, adhering closely to the following principles, respecting not only the schedules and the legitimate interests of the publisher, and the *modus operandi* of the editorial staff but also the academic evaluations made by the editorial board of «ALBERTIANA»:*

1. Unless expressly agreed, anyone who proposes in any form and by any means an article of any kind for publication in «ALBERTIANA» guarantees that article to be *ipso facto* previously unpublished and free from claims of any kind, at the same time ensuring that until the article itself is published in «ALBERTIANA» or the editorial board of «ALBERTIANA» communicates its rejection, they will not offer it to another journal or to another publisher for publication.
2. The line and editorial characteristics of «ALBERTIANA», its editorial guidelines, style, *usus* and *modus operandi* are defined, in agreement with the publisher and with the owner of the journal, not by individual authors, but by the *Committee of editors and readers* on one hand, and by the *Executive committee (editorial)* of «ALBERTIANA» on the other, and they alone decide the final structure of the individual issues.
3. Anyone who proposes in any form or by any means an article of any kind for publishing in «ALBERTIANA» expresses *ipso facto* their unequivocal agreement that as far as required, such a contribution may be adapted by the appropriate committees in accordance with the editorial guidelines, *usus* and style of the journal. This unbreachable agreement, a true *conditio sine qua non* of any publication in the journal, is regarded as being entered into beforehand and without reservation, thus irrevocably.
4. In the absence of an explicit agreement otherwise, *the authors remain the owners of the rights pertaining not only to the content of their contributions* but also to the additions and improvements introduced by the editors of the journal in preparation for printing, *with the following restrictions*, which they contractually allow by the very fact of publishing in «ALBERTIANA»:



- a. For twenty-four months after publication of the articles proposed and editorially adapted to the journal's academic and editorial standards by the bodies in charge of these activities, the authors undertake to refrain from republishing their contributions themselves in any way. Any exceptions to this principle must be requested directly of the Editors of the journal, and permission will be granted only when plausibly justified and appropriate.
- b. After this twenty-four month period, the authors may do as they wish with the content of their articles printed in «ALBERTIANA» on three conditions:
 - They inform in advance the Publisher and/or Editors of the journal of each new edition and/or any further reprints planned and undertaken.
 - They mention the fact of previous publication in «ALBERTIANA» in each new edition or reprint, and do so in a complete and correct way, clearly and in an appropriate place.
 - They immediately send the Publisher and/or Editors of the journal a copy of the new edition or reprint of the article in question.
- c. *Since no rights are granted by the publisher of the journal regarding the files in PDF sent to the authors* in the preparation phase before printing, or once printed provided to the authors as excerpts consisting of their individual contributions, each author of «ALBERTIANA» expressly recognizes that these *PDF* files received with simple permission for personal or competitive use are the exclusive property of the publisher and copyrighted. Consequently, each author of «ALBERTIANA» who receives one or more extracts in *PDF* from the publisher of their contributions is committed to using them exclusively for the benefit of themselves and their own intellectual and scholarly work, strictly refraining from making them publicly accessible. Thus irrevocably acting as a diligent and jealous guardian upon the very act of receiving, s/he therefore undertakes not to formally deposit them on the web or internet or make them available to either public or private institutions, libraries or bodies.
